Wooden Boxes Prepared having Bubble Wraps and Plastic Wrapping for Cushioning Effect and No External Contaminants Enter the Product.</li><li>• Spares are Added along with the Box Container (if Considered)</li><li>• Fumigation of the Wooden Box for Exports with Certificate is Prepared.</li></ul>
